The VSA Kentucky Artist Registry is a directory of adult artists with disabilities throughout the Commonwealth of Kentucky. Inclusion on the Artist Registry will make you and your work known to VSA Kentucky should the appropriate opportunity arise. The Artist Registry is a resource directory and does not guarantee that your work will be selected for exhibition or performance. Your listing on the Registry provides an opportunity for your work to be seen or heard and will allow us to keep you posted on exhibition, performance, artistic and professional development opportunities as they become known to us.

### General Guidelines

1. Visual Arts: Work in all sizes and media will be considered for the registry.
2. Performing Arts: Performance work in music, drama and dance will be considered for the registry.
3. All visual artwork must be original. All works must be attributable to the artist.
4. All work samples (video tapes, slides, CDs, color photocopies, audio tapes) become the property of VSA Kentucky.

**Theatre:** Please include **two** copies of your DVD or videotape of your work. Provide a headshot of yourself or a photograph of just you in performance to be showcased online.

**All Artists: *All samples from all arts disciplines must be of subject matter that would be appropriate for a general audience: Children through adults.***

Do you have any formal training in the arts? If yes, please describe.

**Teaching and/or formal arts training are not requirements for our registry. We welcome and encourage self-taught artists.**
